- 1. **PHONE:** Credit card gifts can be accepted by phone. The telephone number is: 888-252-6174
- 2. **CHECK**: Make your check payable to ADVANCE GCFA. Write the name of the project and Advance number on the memo line of the check. Send your check to the address below:

- 3. **ONLINE**: You can give to any of the ministries, missionaries and projects currently supported by The United Methodist Church through Global Ministries by visiting www.umcmission.org/give.
  - a. To set up an online reoccurring (monthly) gift online, please follow the steps below:
    - 1. Search for a project by visiting <a href="www.umcmmission.org/give">www.umcmmission.org/give</a>
    - 2. Select the "GIVE NOW" button on the upper right hand side of the project's webpage
    - 3. Under gift duration, select "This is a monthly gift." Below is a screen shot of the section you should be looking at:
